### 1. Scope of Services

- Bridal Party Makeup (if requested)
- Touch-ups (if applicable)

# 2. Pricing and Payment

- Less than 30 days before the event: No refunds will be provided for the deposit, and 100% of the remaining balance will be due.
- If the Makeup Artist is unable to fulfill the services due to unforeseen circumstances (e.g., illness), a full refund will be issued to the Client, or the Makeup Artist will make reasonable efforts to provide a substitute artist.

### 4. Travel and Location

- **Travel Fee:** The Makeup Artist will travel to the event location for no additional charge within a [X]-mile radius of [City, State]. Any travel outside of this radius will incur a travel fee of \$[Amount] per mile.

The Client grants permission for the Makeup Artist to take before and after photos of the makeup application for portfolio and marketing purposes. If the Client does not wish to allow photos, they must inform the Makeup Artist in writing prior to the wedding date.

## 9. Force Majeure

Neither Party will be held liable for any delays or failures to perform their obligations under this Agreement due to unforeseen circumstances, including but not limited to, natural disasters, accidents, or other events beyond their control.

# 10. Dispute Resolution

In the event of a dispute, the Parties agree to resolve the matter through [mediation/arbitration] before pursuing other legal remedies.

# 11. Entire Agreement

This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements or understandings, whether written or oral. Any changes or additions to this Agreement must be made in writing and signed by both Parties.
